# Giving Opportunities

\$3,000 - \$5,000

- \$3,000 provides one year of PrEP medication for 10 uninsured clients
- **\$4,000 supports the costs of PrEP care for 2 clients** unable to access insurance due to safety concerns (such as LGBTQ+ people ages 18-25 who cannot safely come out to their families)
- \$5,000 provides two months of meals at our Higher Ground Day Center
- **\$5,000 supports a year of transportation** assistance to/from appointments for 100 clients

\$1,000 - \$2,999

- \$1,300 is a year of case management support for a person living with HIV
- **\$1,800 covers medical costs and fees associated with one year of PrEP** care for any client
- **\$2,500 provides one month of meals** at our Higher Ground Day Center
- **\$2,999 covers the cost of 750 STI tests** (nearly half of the tests performed by THP in 2021)

• **\$700 supports the cost of one year of marketplace insurance** provided to uninsured clients enrolled in PrEP services

- **\$800 supports a year of utility and rent assistance** for an HIV case management client in need
- \$999 sustains a month of in-person sexual health prevention, education, and outreach interventions in our community

- **\$300 provides a year's worth of groceries** for a client enrolled in our HIV case management
- **\$300 provides one year of PrEP medication** for a client without insurance
- \$300 provides judgment-free pregnancy testing for 30 people.
